THIS DEED OF TRUST made and executed on this the day of Twenty Ninth of November one thousand nine hundred and ninety Six at NEW HORIZON EDUCATION AND AGRICULTURAL RESEARCH TRUST :

The First, and Second Trustees be together hereinafter called the "Authors of the Trust" which term shall mean and include their heirs, legal representatives, successors in interest, executors, administrators and assigns of the ONE PART :

WHEREAS the Authors of the Trust belong to Sindhi Community and have created this Trust also with an interest to promote Sindhi language and Culture among other incidental objectives by establishing, acquiring, managing Educational Institutions for the benefit of persons belonging to Sindhi Community and by providing them facilities of education, agricultural research and development, leading to employment facilities to them in particular and others in general.

g) Consider and approve the accounts of the Trust periodically once in every year after getting the accounts scrutinised and audited by a Chartered Accountant.

THE COUNCIL OF TRUSTEES SHALL nominate a Committee called COMMITTEE OF MANAGEMENT and shall vest the Committee so constituted the power of management of a particular institution of the Trust.

VIII) CONSTITUTION, POWER, DUTIES OF THE COMMITTEE OF MANAGEMENT :

a) The Committee of Management shall have as many members as may be necessary to comply with the rules made by governing the management of the institution.

b) The Committee of Management shall work subject to the control of Trustees and any decision taken by the Committee shall become operative and executable only after it is approved by the first Author Trustee.

c) The member appointed or nominated by the Trustees for the Committee of Management shall hold the office for the period of one year.

d) The Committee of Management of the Institutions run by the Trust shall look after all acts, deeds and things that are due and necessary for the efficient and due administration of the Institution under its control.

e) The Committee of Management shall consist of specialists in the field in which the institutions impart studies or specialises. It shall also consists of efficient administrators and educationists and such of the persons that the council of Trustees deem fit for due implementation of the scheme of the Trust and efficient administration of the Trust and its Institution.

IX) If for any reason, the objects of this Trust created cannot be fulfilled, the First Author of Trust shall be at liberty to apply the Trust funds and the properties which is the subject of the Trust, to any other objects of like nature which he shall consider proper.

The total FUND of the Trust dedicated by the Author of Trust is Rs. 5,000/- (Rupees Five Thousand only).

X) In the event of dissolution or winding up of the Trust/Society, assets remaining as on the date of dissolution shall under no circumstances be distributed among the trustees/members of the Managing Committee/Government Body but the same shall be transferred to another charitable Trust/Society whose objects are similar to those of this Trust/Society.
